

Mantra Group Limited to be removed from the S&P/ASX 200 Index

SYDNEY, MAY 18, 2018: S&P Dow Jones Indices announced today that it will remove Mantra Group Limited (ASX: MTR) from the S&P/ASX 200, subject to final court approval of the scheme of arrangement whereby the company will be acquired by AAPC Limited, a subsidiary of Accor S.A. (PAR: AC).

S&P Dow Jones will remove Mantra Group Limited from the S&P/ASX 200 effective at the open of trading on May 24, 2018. Mantra Group Limited will be replaced by IDP Education Limited (ASX: IEL) in the S&P/ASX 200 effective at the open on May 24, 2018.
