

CIMIC Group Limited to be removed from the S&P/ASX 200 Index

SYDNEY, APRIL 07, 2022: S&P Dow Jones Indices announced today that it will remove CIMIC Group Limited (XASX: CIM) from the S&P/ASX 200, as a result of the board approved, off-market takeover offer from HOCHTIEF Australia Holdings Limited.

S&P Dow Jones Indices will remove CIMIC Group Limited from the S&P/ASX 200 effective prior to the open of trading on Tuesday, April 12, 2022. CIMIC Group Limited will be replaced by HomeCo Daily Needs REIT (XASX: HDN), in the S&P/ASX 200 effective prior to the open of trading on Tuesday, April 12, 2022.
