

## S&P Dow Jones Indices Announces June 2019 Quarterly Rebalance of the S&P/ASX Indices

**SYDNEY, JUNE 14, 2019:** S&P Dow Jones Indices (“S&P DJI”) announced today the changes in the S&P/ASX indices, effective at the open of trading on June 24, 2019. At this rebalance, the S&P/ASX 200 index hierarchy and the S&P/ASX All Australian indices were reviewed.

S&P DJI will also remove Navitas Limited (XASX: NVT) from the S&P/ASX indices, subject to shareholder and final court approval of the scheme of arrangement whereby the company will be acquired by an investment consortium. Navitas Limited will be replaced by Austal Limited (XASX: ASB) in the S&P/ASX 200 and Gold Road Resources Limited (XASX: GOR) in the S&P/ASX All Australian 200. These changes will be applied simultaneous with the June rebalance, effective at the open on June 24, 2019.
